On scrutiny of the applications received in this office, candidates found eligible in all respect will be called for viva-voce or any other mode of selection as decided by the Competent Authority:-

1. These posts will be filled up purely on temporary transfer basis for a period of 5 years from the serving Railway employees in same Grade/Grade pay. However, they are liable to be repatriated prematurely to their parent cadre in either of the following circumstances:-
 - (a) By Railway Claims Tribunal for any administrative reasons including on grounds of unsatisfactory work of the staff concerned and
 - (b) When the employee concerned is due for promotion in his/her parent cadre and there is no post available in RCT to accommodate him/her on promoted post.
2. The lien/seniority will continue to be maintained at respective parent department of the employee.
3. There should be no D&AR/SPE/Vig case pending against the applicants.
4. The application should be filled up neat and clean in the given Proforma annexed as 'A'.
5. Willing staff should have one year or more remaining service before their date of superannuation.
