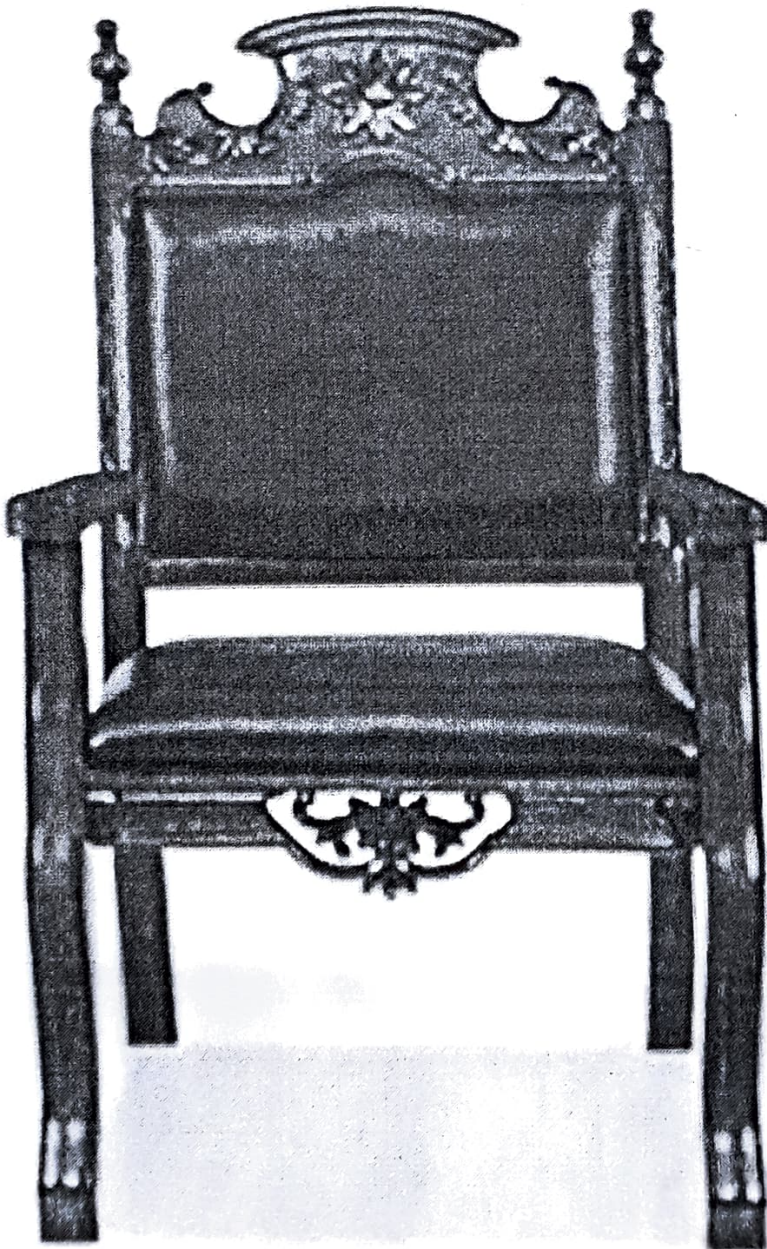
1	Chair should be in wooden material made in teakwood with melamine polish and color as per choice. Sample of chair to be supplied is annexed as A-1.

4	The estimated total cost of the Chair is Rs.18,200/- including GST, transportation charges for supply of chair in this office and all other charges.
