TERMS AND CONDITIONS FOR ENGAGEMENT OF DATA ENTRY OPERATOR (DEO) ON CONTRACTUAL/OUTSOURCING BASIS IN RAILWAY CLAIMS TRIBUNAL-DELHI

1. The candidates must be a graduate with knowledge of Hindi language and Hindi Shorthand along with the knowledge of computers/IT applications.
2. Salary : the salary will be paid @ Rs. 25,000/- per month per person to the outsourced Skilled/Graduate worker. Total salary to be paid to a DEO will be as per his actual attendance in RCT.
3. The working hours of DEOs will be 8 hours per day from 09:30 to 18:00 Hrs. with half an hour lunch break from 1330 to 14:00 Hrs. on all working days.
4. Since RCT is a judicial organization, it has to be made clear to the candidates that any leak of confidential information may lead to legal action including prosecution against them.
5. The engagement will be for a period of 11 months and can be renewed with a break engagement. .
6. Giving one month prior notice by either party can terminate this contractual engagement.
7. Engagement of DEOs under the scheme will not constitute any offer of appointment in RCT or Railways.
8. Recovery has to be made from the monthly wage of the candidate for any willful damage/loss to equipment or property that may be caused by the persons engaged.
