Sub : Engagement of Gr.D Staff (Peon) on Contractual/Outsourcing basis in Railway Claims Tribunal, Guwahati Bench.

Railway Claims Tribunal, Guwahati Bench will conduct a Walk-in Interview for the post of Peon to be engaged on contractual basis as per terms & conditions of Principal Bench's letter no.RCT/DLI/Admn.Policy/2016 dated 27.12.2023, as per the details given below:-

- i) Candidates who are fulfilling the eligibility conditions may apply to the contractual Peon post by submitting the application in the prescribed format enclosed as **Annexure B**.
- ii) Candidates are requested to send their applications/CV/resume in one page only to be mailed to RCT/GHY on its E-mail address **rctgbrecruitment@gmail.com**. (Application by post, by Hand or any other means will not be entertained at all).
- iii) If any information in the application is found false, the service of the candidate will be terminated immediately without assigning any reasons and appropriate action will be taken against him/her.
- iv) Applicants whose applications are found in order shall be considered for calling for walk in Interview along with Original documents.
- v) The interview to be conducted is only shortlisted candidates and no TA/DA will be given to the candidates. Candidates will have to make their own arrangement.
- vi) Last date of submission of application is **18.03.2024**.
- vii) Applications received after due date shall not be considered.

Terms & conditions for engagement of Group-D staff on Contractual/outsourcing basis in RCT against vacant post of Peons/Safaiwalas

1. The qualification for the Peon should be 10th class pass and persons with less than 10th class (unskilled) should be engaged as Safaiwalas.
2. Remuneration for the outsourced Peons and Safaiwalas will be governed by the minimum wages in force in the state in which engagement is to be undertaken.
3. The Railway working hours will be 8 hours per day from 9:30 hrs to 18.00 hrs with half an hour lunch break from 13:30 to 14:00 hrs on all working days.
4. Since RCT is judicial organization, it has to be made clear to the candidates that any leak of confidential information may lead to legal action including prosecution.
5. If the person engaged/hired remains absent, pro-rata deduction will be made from the amount payable to him/her. The amount of deduction will be worked out on the basis of 1/30th of the lump sum amount per day of absence.
6. Giving one month's prior notice by either party can terminate this contractual engagement.
7. The above contractual arrangement would be for a period not exceeding 11 months from the date of acceptance of the terms and conditions for such engagement or till the posts are filled by Zonal Railways, whichever is earlier. Suitable break should invariably be given between two successive contracts (if any).
8. Engagement of persons under this scheme does not constitute any offer of appointment in Railway Claims Tribunal or Railways.
9. Recovery has to be made from the monthly wages for any willful damage/loss of equipment or property that may be caused by the persons engaged.
10. The age of the candidates for engagement of Group D staff on contract/outsourcing basis should be minimum of 18 years and maximum 45 years as on the date of notification.
11. Candidates may be engaged only after a medical fitness certificate issued by a General Physician having a minimum MBBS Degree.
12. While assessing the suitability of a candidate, RCT Benches will make the list of standby (wait list) candidates who may be considered for engagement against the post of future vacancies.

The validity period for engagement for Peons and Safaiwalas on an outsourced basis is upto 27.04.2027.

Benches may take up the matter with the Zonal Railway under whose jurisdiction of RCT Benches located for filling up these vacancies from regular railway employees.
