Office Order

Hon'ble High Court of Delhi vide its order dated 11.02.2022 has issued the directions regarding system of hearing of cases before its District/ Subordinate courts with effect from 14.02.2022 upto 28.02.2022 . As per directions, the District/Subordinates courts shall prepare the roster in such a manner that around 50% of the total strength of the judicial officer shall hold the court physically while the others take up the matter through virtual mode. In accordance with the aforementioned directions , it has been decided by the competent authority that the system of hearing of cases in Principal Bench of RCT Delhi shall be as under w.e.f 14.02.2022 to 28.02.2022.

Bench-I

1. Sh. Vijay Kumar, Hon'ble Member (Tech.), RCT, Delhi shall hold Single Member Bench physically from 14.02.2022 to 18.02.2022 at 10:30 hours onwards.
2. Hon'ble Chairman and Sh. Vijay Kumar, Hon'ble Member (Tech.), RCT, Delhi shall hold Division Bench virtually on 23.02.2022 and 24.02.2022 at 10:30 hours onwards.
3. Sh. Vijay Kumar, Hon'ble Member (Tech.), RCT, Delhi shall hold Single Member Bench virtually on 21.02.2022, 22.02.2022, 25.02.2022 and 28.02.2022 at 10:30 hours onwards.

Bench-II

1. Sh. Sunil Mathur, Hon'ble Member (Tech.), RCT, Delhi shall hold Single Member Bench virtually from 14.02.2022 to 18.02.2022 at 12:30 hours onwards.
2. Sh. Sunil Mathur, Hon'ble Member (Tech.), RCT, Delhi shall hold Single Member Bench physically from 21.02.2022 to 28.02.2022 at 12:30 hours onwards.

In Virtual Court, all cases other than those at Evidence stage, shall be listed. This has the approval of Hon'ble Chairman.
